**RESERVATIONS** To reserve space on any trip, return the completed form with your \$400.00 per person deposit to Vacations International Inc. Reservations can be accepted usually up to 21 days prior to departure, though many trips fill up early. We urge you to make reservations well in advance, as space is limited.

**CANCELLATION** If you must cancel your trip, your deposit and all payments will be refunded, less a cancellation fee. If written notice of cancellation is received in our office more than 60 days prior to departure, the fee is \$200. 59-29 days- 25% of the total tour cost, between 28 – 16 days before departure, the fee is 75% of the total tour cost, between 15 to 1 day before departure the fee is 85% of the total tour cost. No refunds for no shows.

**Trip cancellation & interruption insurance is recommended** and available at modest rates. Vacations International Inc. reserves the right to cancel any trip due to insufficient sign-ups, though a supplemental charge can be paid to operate a trip below our minimum. **We strongly recommend you protect yourself and your baggage with a travelers insurance policy.** Baggage is carried entirely at owner's risk. Vacations International Inc. assumes no liability whatsoever for damage, loss or delay of property beyond our control. Trip cancellation insurance will cover your losses on nonrefundable air and land costs on trips.
